**RE: Janus Capital Funds Plc (the "Fund") – Italian New Tax Reporting Regime for Funds and SICAVs investing in eligible bonds (Decree 13 December 2011 – ref. n.11A16232)**

We confirm that, in our capacity as administrator of the Fund, the calculations supplied and set forth in schedules 1 and 2 to this letter have been calculated in accordance with the applicable methodology agreed with the Fund and pursuant to advice received from PWC Italy in order to identify the portion of profits/losses associated with "indirect" investment made by the Fund in eligible bonds.

Based on advice received from PWC Italy, we, in our capacity as administrator of the Fund, have calculated the relevant percentage on the basis of the "Gross Asset Value" on behalf of the Fund as per the two last available semi-annual and annual audited financial statements of the Fund.

For the audit period commencing January 1, 2016, the percentage is based on the semi-annual financial statements dated June 30, 2015 and annual audited financial statements December 31, 2014. The "Gross Asset Value" used to calculate the relevant percentage is determined by adding liabilities to the net asset values reported in the relevant financial statements.

This letter and schedules thereto are provided by Citibank Europe plc solely in its capacity as administrator and fund accounting agent to the Fund appointed by the Fund pursuant to an amended and restated administration agreement between the Fund, Janus Capital International Limited (as the Fund's investment adviser, distributor and promoter) and Citibank Europe plc.
